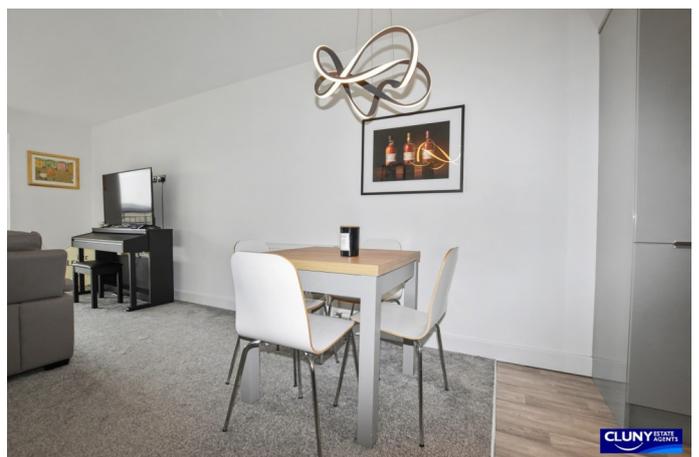

Factoring fees of around £21 per month are payable for maintenance of the communal areas.

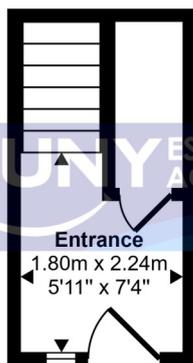
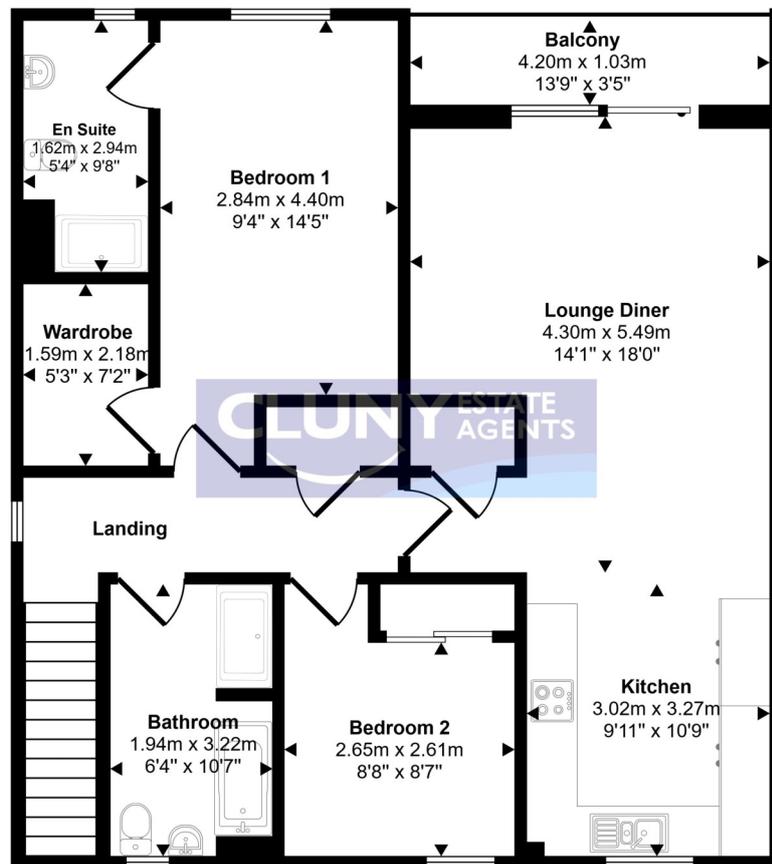
